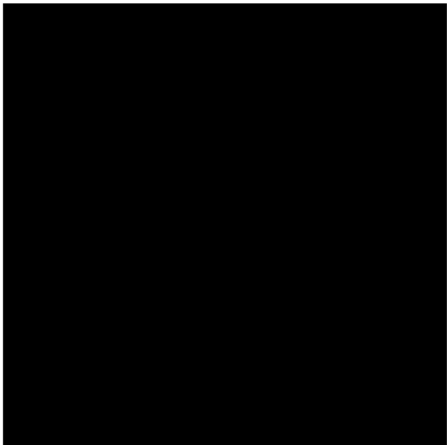
RESOLUTION 07-04-01-98
