RESOLUTION 07-04-09-98

A RESOLUTION TO AUTHORIZE THE MILLE LACS BAND OF OJIBWE INDIANS TO RECEIVE DOMESTIC ASSISTANCE GRANTS OR CONTRACTS FROM THE STATE OF MINNESOTA.


- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, the Mille Lacs Band of Ojibwe Indians is authorized to execute and administer contracts pursuant to the provisions of Article VI, Section (c) of the Constitution of the Minnesota Chippewa Tribe and Mille Lacs Band Statute; and,
- WHEREAS, funds are available through the State of Minnesota to provide programs and services to address the needs of the Mille Lacs Band of Ojibwe Indians; and,
- WHEREAS, the Mille Lacs Band of Ojibwe Indians desires to provide domestic assistance programs to the members of the Band in the following areas: C.D. Treatment Programs, Mental Health Programs, Child Welfare Programs, Women, Infants and Children (WIC), Energy Assistance, Weatherization and Block grants.

NOW, THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby desires to enter into a contract with the State of Minnesota for domestic assistance programs for the benefit of the Mille Lacs Band members; and,

BE IT FURTHER RESOLVED, that the Commissioner of Administration and the Commissioner of Human Services are authorized to sign on behalf of the Mille Lacs Band of Ojibwe; and,


BE IT FURTHER AND FINALLY RESOLVED, that in the absence of the Commissioner of Administration, it is hereby authorized that the Assistant Commissioner of Administration be authorized to sign on behalf of the Commissioner of Administration.
