RESOLUTION 08-02-135-98

A RESOLUTION GRANTING A PERMIT GTE AUTHORIZING NEW TELEPHONE SERVICE LINE WITHIN STATE OF MINNESOTA RIGHT-OF-WAY FOR HIGHWAY 169.

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the number one priority of the Mille Lacs Band is to improve the overall quality of life for the people of the Mille Lacs Reservation; and,

WHEREAS, the GTE is desirous of obtaining a right-of-way for the use the premises in connection with said land leases; and,

WHEREAS, 21 MLBSA § 204, designates rules and regulations governing the issuance of right -of-way across lands under the jurisdiction of the Band; and,

WHEREAS, pursuant to the statutory authority, the Commissioner of Natural Resources has reviewed the request of the GTE and does hereby recommend that the Chief Executive approve said right-of-way request.

NOW, THEREFORE BE IT RESOLVED, that the request for a right-of-way across lands herein described as:

A permit authorizing GTE to lay new cable within the Right-of-way issued to the State of Minnesota for Highway 169, providing telephone services in areas that will benefit the Mille Lacs Band of Ojibwe. The cable is to be laid in coordination with the reconstruction project for that highway anticipated beginning fall of 1998. The proposed route affects the approved Highway 169 right-of-way through the following allotted parcels of land currently in trust and heir-ship status. See also map attached as Exhibit A.
