RESOLUTION 08-01-53-98

A RESOLUTION IN SUPPORT OF THE NE-IA-SHING CLINICS PARTICIPATION IN THE NORTHEAST MINNESOTA TRIBAL HEALTH PLANNING PARTNERSHIP FOR THE PURPOSE OF MEETING COMMON HEALTH NEEDS AND THE PARTNERSHIPS' SUBMISSION OF A TRIBAL MANAGEMENT GRANT TO THE INDIAN HEALTH SERVICE

WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe; a Federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly recognizes the changes occurring in the Indian Health Service and the regional, state and federal health care funding arenas; and,

whereas, the Mille Lacs Band Assembly recognizes the need for or inter-tribal health planning, opportunities for mutual assistance and ways to become more influential in regional, state and federal health care policy initiatives; and,

WHEREAS, the goals of this program are to establish the Northeastern Minnesota Tribal Health Planning Partnership and submit a tribal Management Grant to assist in the Partnership development and health planning for the Partnership tribes.

NOW, THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby wholeheartedly supports and endorses participation in the Tribal Partnership, consisting of the Mille Lacs, Bois Forte, Grand Portage and Fond du Lac Tribes of Minnesota; and,

BE IT FURTHER AND FINALLY RESOLVED, that the Mille Lacs Band of Ojibwe supports and endorses the Fond du Lac Bands' Tribal Management Grant proposal to the Indian Health Service for the development of the Partnership and a cooperative health planning initiative.

IN WITNESS WHEREOF, I, the Chief Executive hereunto set my hand to this resolution and forward to the Band Assembly for concurrence.
