RESOLUTION 07-04-03-98

A RESOLUTION GRANTING THE RELINQUISHMENT FROM THE MILLE LACS BAND, MILLE LACS RESERVATION TO THE ST. CROIX RESERVATION.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe Indians, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applications for relinquishment from the Mille Lacs Band, Mille Lacs Reservation; and,

WHEREAS, Merrill, Milo Sr. Dob: [REDACTED] have signed a relinquishment form with the Minnesota Chippewa Tribe and relinquishes and surrenders any and all rights, title and interest that they may have in any undistributed property and assets of the Mille Lacs Band, Mille Lacs Reservation of the Minnesota Chippewa Tribe; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does determine that these relinquishments are proper and that the interest of the individuals have been considered and that these individuals do meet the requirements for membership with the St. Croix Reservation and does approve the granting of the relinquishments for the above individuals.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 9th day of April, 1997 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
