RESOLUTION 07-04-21-98

A RESOLUTION APPROVING THE ENROLLMENT INTO THE MILLE LACS BAND MILLE LACS RESERVATION, DUE TO AN INCREASE IN THEIR BLOOD QUANTUM.

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applicants to be reconsider for enrollment; and,
- WHEREAS, The Mille Lacs Band Assembly has reviewed the application to reconsider the blood quantum for Souttida Kathryn Norasingh based on the affidavit of Michael Allen Van Pelt father of the applicant.
- WHEREAS, Souttida Kathryn Norasingh DOB [REDACTED] shall have her blood quantum increased from [REDACTED] Refer to Resolution 05-03-71-93
- WHEREAS, the changes should be made on the records of the Minnesota Chippewa Tribe.


