RESOLUTION 08-02-127-98

**A RESOLUTION FROM THE MILLE LACS BAND
OF OJIBWE INDIANS AUTHORIZING THE MILLE
LACS TRIBAL POLICE DEPARTMENT TO
PARTICIPATE IN THE ALCOHOL SATURATION
PROGRAM DESIGNED TO ARREST IMPAIRED
DRIVERS (OPERATION NIGHTCAP).**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe Indians, a federally recognized Indian Tribe;
- WHEREAS, the Mille Lacs Band keeps law and order on the Reservation and surrounding communities through its Tribal Police Department;
- WHEREAS, It has been determined that resources administered by the State of Minnesota can help in decreasing costs incurred by the Band for law enforcement;
- WHEREAS, the State administers a grant program which promotes inter-agency cooperation between various law enforcement agencies to combat drunk driving;
- WHEREAS, the Tribal Police have demonstrated a proficiency and interest in arresting impaired drivers and agreed to participate in the program;
- WHEREAS, the State will reimburse grantees for hours worked by Officers in agencies participating in the grant; and
- WHEREAS, Tribal Police provided one Officer on Opening Fishing on May 9, 1998 for the program.
- NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band Assembly recognizes the need for safe roads and sober drivers and designates and authorizes Chief Bruce D. Lindgren to execute the Operation NightCAP contract for the participation in the alcohol saturation program designed to arrest impaired drivers.
