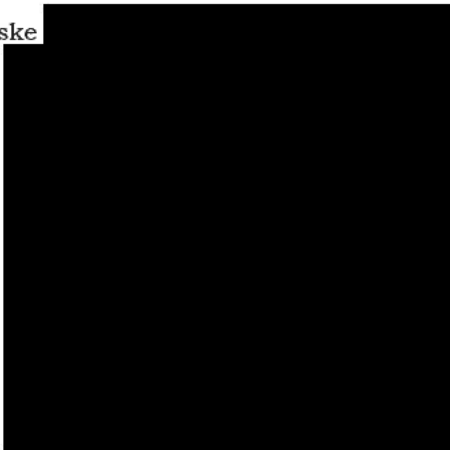
RESOLUTION 07-04-19-98

A RESOLUTION APPROVING THE ENROLLMENT INTO THE MILLE LACS BAND OF OJIBWE FOR THOSE WHO MEET THE 1/4 DEGREE REQUIREMENTS OF THE MINNESOTA CHIPPEWA TRIBE.
