RESOLUTION 08-02-137-98

A RESOLUTION GRANTING A RIGHT-OF-WAY TO GTE FOR NEW SERVICE CABLE LINE.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, the number one priority of the Mille Lacs Band is to improve the overall quality of life for the people of the Mille Lacs Reservation; and,
- WHEREAS, the GTE is desirous of obtaining a right-of-way for the use the premises in connection with said land leases; and,
- WHEREAS, 21 MLBSA § 204, designates rules and regulations governing the issuance of right –of-way across lands under the jurisdiction of the Band; and,
- WHEREAS, pursuant to the statutory authority, the Commissioner of Natural Resources has reviewed the request of the GTE and does hereby recommend that the Chief Executive approve said right-of-way request.
- NOW, THEREFORE BE IT RESOLVED, that the request for a right-of-way across lands herein described as:

A right-of-way specifically for laying new cable line, providing telphone services to areas that will benefit the Mille Lacs Band of Ojibwe, to be laid in coordination with the reconstruction project for Highway 169, anticipated to start in the fall of 1998. The proposed route affects the following tracts of land owned by the Mille Lacs Band. Right-of-way to be granted pursuant to 25 Code of Federal Regulations Part 169. See also map attached as Exhibit A.
