RESOLUTION 08-03-68-99

**A RESOLUTION REQUESTING SECRETARIAL APPROVAL OF THE
DISTRIBUTION OF CASINO REVENUE.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band has initiated payments to Mille Lacs Band members from gaming revenues; and

WHEREAS, the payments initiated did not comply with Mille Lacs Band law and with federal law or guidelines for the distribution of per capita payments from gaming revenues; and,

WHEREAS, the Band Assembly desires to make bonus distribution payments to Band members in order to assist Band members achieve a better future; and

WHEREAS, the Band Assembly, in order to make distribution payments in a manner consistent with applicable laws, must develop, adopt and submit to the BIA for approval, a Revenue Allocation Plan, authorizing per capita payments; and,

WHEREAS, the Band Assembly desires to adopt and submit for approval a Revenue Allocation Plan.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby adopts the attached Revenue Allocation Plan and requests approval for distribution of Casino revenues to all Mille Lacs Band members.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 23rd day of July, 1999 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of the Assembly to be affixed to this resolution and forwarded to the Chief Executive for Concurrence.
