RESOLUTION 08-04-103-99

A RESOLUTION AUTHORIZING A LAND LEASE TO

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and,
- WHEREAS, tribal land leases are required for the purposes of a homesite, agricultural and seasonal recreational residence, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs Reservation, and;
- WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years subject to the lease provisions, effective upon date of approval, for the purpose of establishing a home located on the property described herein; and,
- WHEREAS, said land is described as follows:

Description of property: A part of Tract # 410 TF 11, Lots 130 & 131, Port Mille Lacs, Section 8, Township 43 North, Range 27 West, Mille Lacs County, Minnesota, approximately 1 acre, more or less.

- WHEREAS, The annual lease rental is \$1.00 and there is a \$2.00 lease processing fee.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to for a period of 25 years and renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and,
- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert back to the Mille Lacs Band of Ojibwe; and,
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and,
- BE IT FURTHER AND FINANLLY RESOLVED, that this will terminate any other residential lease agreement that may be in existence in the name of the lessee.
