RESOLUTION 08-04-102-99

A RESOLUTION RESCINDING RESOLUTION #07-04-13-98 A LAND LEASE FOR

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required for the purposes of a homesite, agricultural and recreational residence/activity, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs Reservation, and;
- WHEREAS, termination determined due to death of Request for ruse in behalf of Mille Lacs Band Member Pending,
- WHEREAS, said land is described as follows:

Description of property: A part of Tract # 410 TF 74, Aitkin County Road 6, approximately 5 miles after 65 N – right hand side of road. Those portions of Lot 14 of the plat of Sheshebe Point 5th Addition, which lies west of the central line of Aitkin County, S.A.R. 6, according to the filed plat thereof.

- WHEREAS, The annual lease rental is \$1.00 and there is a \$2.00 lease processing fee.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a termination of land lease to
- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert back to the Mille Lacs Band of Ojibwe; and,
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and,
- BE IT FURTHER AND FINANLLY RESOLVED, that this will terminate any other residential lease agreement that may be in existence in the name of the lessee.
