RESOLUTION 08-04-99-99

A RESOLUTION RESCINDING RESOLUTION #39-83 AUTHORIZING A LAND LEASE FOR [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required for the purposes of a homesite, agricultural and seasonal recreational residence, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs Reservation, and;

WHEREAS, termination of lease agreement authorized by Resolution #39-83 is necessary due to abandonment; and,

WHEREAS, said land is described as follows:

A part of Tract # 410 T 1015, Lot 1, W $\frac{1}{2}$ NW $\frac{1}{4}$ NE $\frac{1}{4}$. Section 29, Township 41 North, Range 20 West, Pine County, Minnesota.

[REDACTED] the Tenant, resided on the property described herein in a house he had mortgaged with the Minnesota Chippewa Tribe. The mortgage was paid by, and assigned to the Mille Lacs Reservation Housing Authority on February 27, 1992. The mortgaged personal property has been removed and the Tenant has had no further activity on, nor interest in the property described herein since that date.

An alternate site was selected, and a home purchased by the Mille Lacs Reservation Housing Authority for the Tenant which has since served as his residence.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a termination of land lease to be to [REDACTED]

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a of legislators being quorum present held on the 1st of October 1999 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


