RESOLUTION 08-02-34-99

A RESOLUTION FROM THE MILLE LACS BAND OF OJIBWE AUTHORIZING AN AGREEMENT WITH THE MINNESOTA STATE DEPARTMENT OF HUMAN SERVICES FOR FUNDING TO PROVIDE MINNESOTA FAMILY INVESTMENT SERVICES AS PART OF THE BAND'S TANF PLAN AS DEVELOPED UNDER THE PERSONAL RESPONSIBILITY AND WORK OPPORTUNITY RECONCILIATION ACT OF 1996 (PUBLIC LAW 104-193).

WHEREAS, the Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Mille Lacs Band recognizes that the problems of generational dependence on public assistance, high unemployment, lack of marketable skills and lack of occupational training have caused serious social, economic and other hardships for residents of the Mille Lacs Band's communities; and

WHEREAS, the Personal Responsibility and Work Opportunity Reconciliation Act provides an opportunity for the Band to develop and administer a program that will assist eligible needy families to overcome the barriers caused by those problems; and

WHEREAS, the State of Minnesota has offered a contract to the Band to assist them in the administration and provision of TANF and related services by providing state matching funds; and

WHEREAS, the Mille Lacs Band has demonstrated its commitment to the promotion of self-sufficiency for all its band members and their children by developing a TANF program and committing Band funds to the efforts of tribal welfare reform; and

WHEREAS, in conjunction with the State a contract has been developed that will be effective January 1, 1999 through September 30, 2001 that fulfills the requirements of the Act as it pertains to tribally operated TANF programs for the eligible tribal households in Aitkin, Benton, Crow Wing, Mille Lacs, Morrison and Pine counties; and

NOW THEREFORE BE IT RESOLVED, that the Band Assembly recognizes the need for employment, training and assistance activities consistent with the intent of the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (Public Law 104-193) and any subsequent amendments approved and regulated.

BE IT FURTHER RESOLVED, that the Mille Lacs Band's Commissioner of Education or Commissioner of Administration is authorized to sign off on all related contracts and agreements pertinent to TANF on behalf of the Mille Lacs Band.


