**A RESOLUTION IN SUPPORT OF THE PROVISION OF A CHEMICAL  
DEPENDENCY OUTPATIENT TREATMENT PROGRAM FOR ALL  
AGES AND TO INCLUDE PREVENTION AND  
INTERVENTION/TREATMENT FOR ADOLESCENTS ON THE MILLE  
LACS RESERVATION.**


WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe; a federally-recognized Indian Tribe; and,

WHEREAS, the number one priority of the Mille Lacs Band Assembly is to improve the overall quality of life for the people of the Mille Lacs Reservation; and,

WHEREAS, the Mille Lacs Band Assembly recognizes the need to provide comprehensive community chemical dependency outpatient treatment services including aftercare for all ages; and,

WHEREAS, the Mille Lacs Reservation Human Services department has operated and maintained the Chemical Dependency Department since 1978, and has competent and trained staff to operate and administer the outpatient treatment program.

NOW, THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Ojibwe fully supports the program and the proposal to the Chemical Dependency Division of the Minnesota Department of Human Services for Mille Lacs Chemical Dependency Outpatient Treatment to receive Consolidated Treatment funding for the clients referred to the program.
