**RESOLUTION 08-02-07-99**

**A RESOLUTION GRANTING TRANSFER OF ENROLLMENT TO THE  
WHITE EARTH RESERVATION FROM MILLE LACS RESERVATION.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe Indians, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following application for transfer from the Mille Lacs Band to the White Earth; and,

WHEREAS, the following individual was enrolled in the White Earth Band on May 19, 1995; and enrolled with the Mille Lacs Band on July 26, 1995.

WHEREAS, based upon the attachments (court documents) and the fact that this individual was enrolled in White Earth Band first, the Mille Lacs Band must allow for the transfer.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above individual to transfer and recommends that the Minnesota Chippewa Tribe and Bureau of Indian Affairs make the required transfer.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 8<sup>th</sup> day of October, 1998 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
