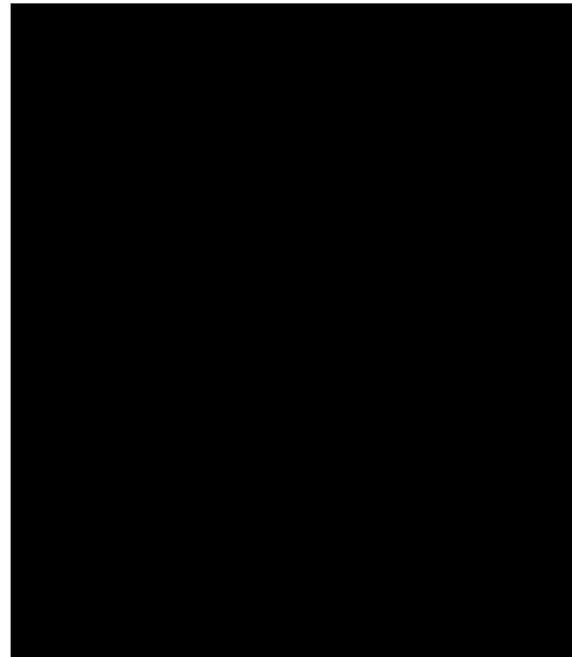
RESOLUTION 08-02-20-99


