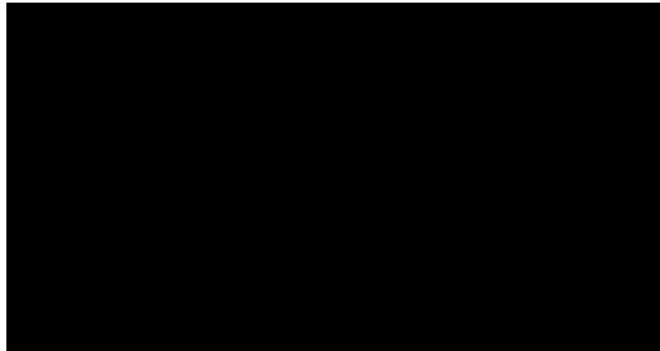
RESOLUTION 08-03-60-99

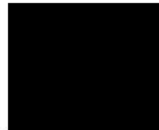


