RESOLUTION 08-03-37-99

A RESOLUTION APPROVING THE ENROLLMENT INTO THE MILLE LACS BAND MILLE LACS RESERVATION, DUE TO AN INCREASE IN THEIR BLOOD QUANTUM.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applications enrollment; and,

WHEREAS, the Mille Lacs Band Assembly has reviewed the applications to reconsider the blood quantum for:

Pindegayaush, George Jr. raising his blood quantum from [REDACTED]
(Nickaboine) Kegg, Vivian Roxanne Dob: [REDACTED] establishing her blood quantum as [REDACTED] and,

WHEREAS, based on the blood quantum increase of Vivian Roxanne (Nickaboine) Kegg, her children, Angela and Andy Nickaboine needs to be considered. Their blood quantum will be [REDACTED] and is eligible for enrollment; and,

WHEREAS, the resolution denying Angela and Andy Nickaboine's enrollment is Resolution 05-03-71-93 dated February 3, 1993; and,

WHEREAS, the changes should be made on the records of the Minnesota Chippewa Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above applications for enrollment and approves all rights provided for the Minnesota Chippewa Tribe enrollees.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 13th day of January, 1999 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
