#### **RESOLUTION 09-01-55-00**

# A RESOLUTION IN SUPPORT OF PARTICIPATION IN THE DEPARTMENT OF TRANSPORTATION INDIAN HIGHWAY SAFETY PROGRAM BUREAU OF INDIAN AFFAIRS FY 2000 GRANT

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band recognizes the importance of developing and supporting programs that are designed to ensure the health, safety and well-being of its Band Members; and,
- WHEREAS, the Mille Lacs Band strives to maintain and support programs designed to protect its most valuable asset, our children; and,
- WHEREAS, the Mille Lacs Band will administer an Indian Highway Safety program grant within the service delivery area of the Mille Lacs Tribal Police Department; and,
- WHEREAS, the Mille Lacs Band will administer an Indian Highway Safety Program grant program implemented by and through the Mille Lacs Tribal Police Department; and,
- WHEREAS, it has been determined that such resources administered by the Band can indeed help lessen the negative impacts of unsafe driving and traffic accidents.
- NOW, THEREFORE IT IS RESOLVED, that the Band Assembly for the Mille Lacs
  Band of Ojibwe Indians concurs with participation with the Department of
  Transportation Indian Highway Safety Program in the project entitled SAFE
  COMMUNITIES during the period from October1, 2000 to September 30, 2001;
  and,
- BE IT FURTHER RESOLVED, that **Todd Roen**, **Acting Solicitor General**, is hereby authorized to execute such agreements as are necessary to implement the proposal on behalf of the Mille Lacs Band Tribal Police Department subject to ratification by the Band Assembly; and
- BE IT FURTHER AND FINALLY RESOLVED, that the Mille Lacs Band Assembly designates the Executive Branch as the Unit of Band Government to administer and conduct the programming under the SAFE COMMUNITIES PROGRAM Grant.
