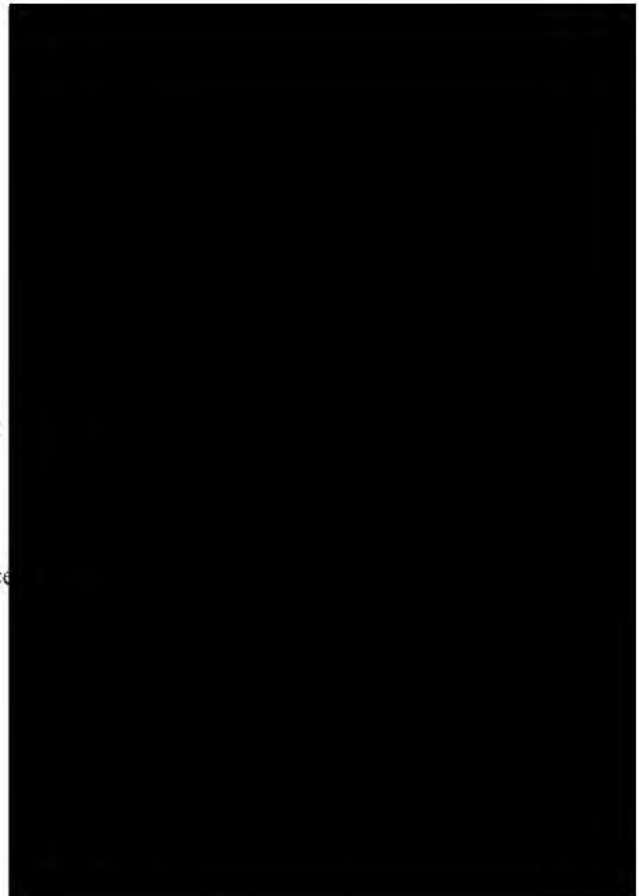
RESOLUTION 09-01-44-00




