RESOLUTION 09-01-36-00

**A RESOLUTION RESCINDING RESOLUTION # 27-84 THAT
AUTHORIZED A RESIDENTIAL LAND LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a homesite or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and;

WHEREAS, Resolution # 27-84 authorized a land lease for residential purposes to [REDACTED] and;

WHEREAS, there is no record of a lease having been completed, and;

WHEREAS, [REDACTED] has been deceased since July 21, 1999, and;

WHEREAS, said land is described as follows:

A part of Tract # 410 T 1002, Beginning at a point 1320.29 feet North of the East quarter corner of Section 28, Township 43 North, Range 27 West, thence North 200 feet, thence West 100 feet, thence South 200 feet, thence East 100 feet to point of beginning, Section 28, Township 43 North, Range 27 West, Mille Lacs County, Minnesota (also described as Block 1, Lot 25, Vineland Hills).

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby rescinds Resolution #27-84 which authorized a land lease to [REDACTED] for the property described herein, due to his demise on July 21, 1999.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 5th of April, 2000 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.




