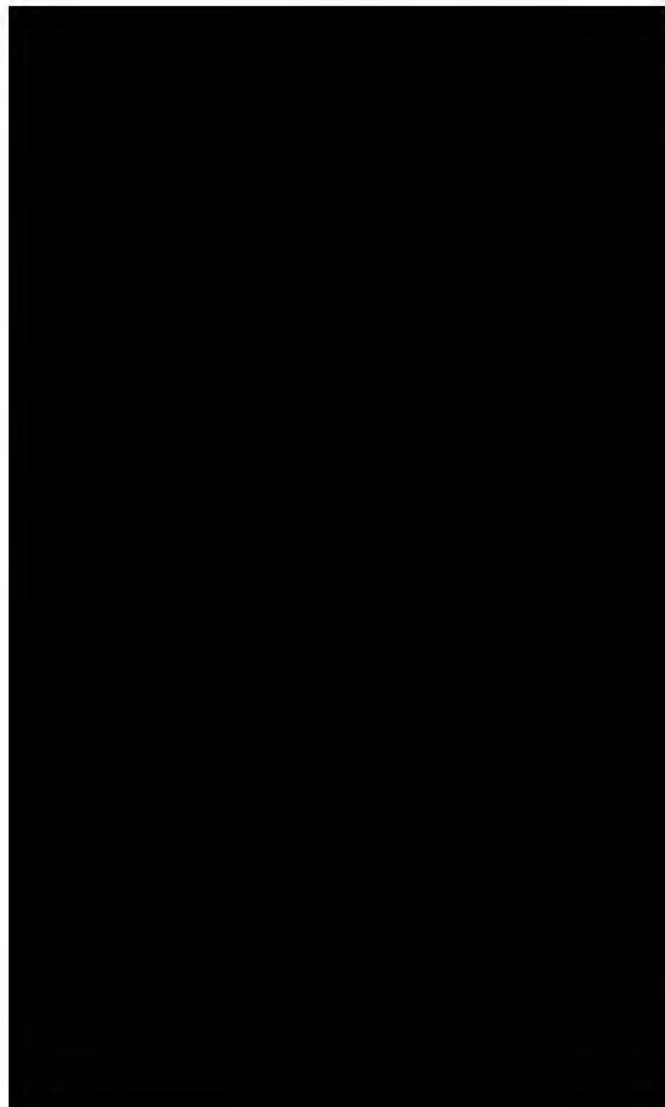
RESOLUTION 08-04-02-00

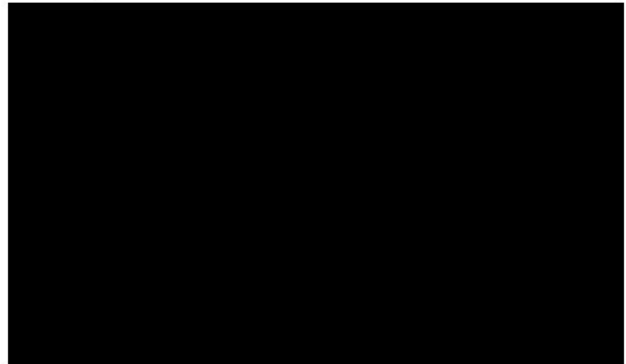




