RESOLUTION 09-01-50-00

A RESOLUTION IN SUPPORT OF A MEMORANDUM OF UNDERSTANDING WITH THE MINNESOTA RURAL HOUSING SERVICE, UNITED STATES DEPARTMENT OF AGRICULTURE

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Band wishes to provide opportunity for its Band members to have affordable housing on land owned by the Band or on land held in trust by the United States of America for the Mille Lacs Band of Ojibwe; and,

WHEREAS, MN RHS wishes to make available to Mille Lacs Band members, program funds to Mille Lacs Band members for the purchase, construction, or improvement of a dwelling, according to program regulations established pursuant to Title V of the Housing Act of 1949, 42 U.S.C. § 1471, *et. Seq.*, which regulations require that all such loans be properly and effectively secure; and,

WHEREAS, the Band has established standards and procedures that apply to the mortgage of a leasehold interest in the land or the dwelling (or both) purchased, constructed, or improved using the proceeds of the loan; and,

WHEREAS, MN RHS requires a Memorandum of Understanding between the Band and MN RHS outlining terms of an agreement regarding these activities; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby supports and directs that a Memorandum of Understanding between the Band and MN RHS be established for the purpose of making available MN RHS program funds to Mille Lacs Band members for the purchase, construction, or improvement of a dwelling, securing the loans with a mortgage to MN RHS of the leasehold interest;

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a of legislators being quorum present held on the 25th day of April at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


