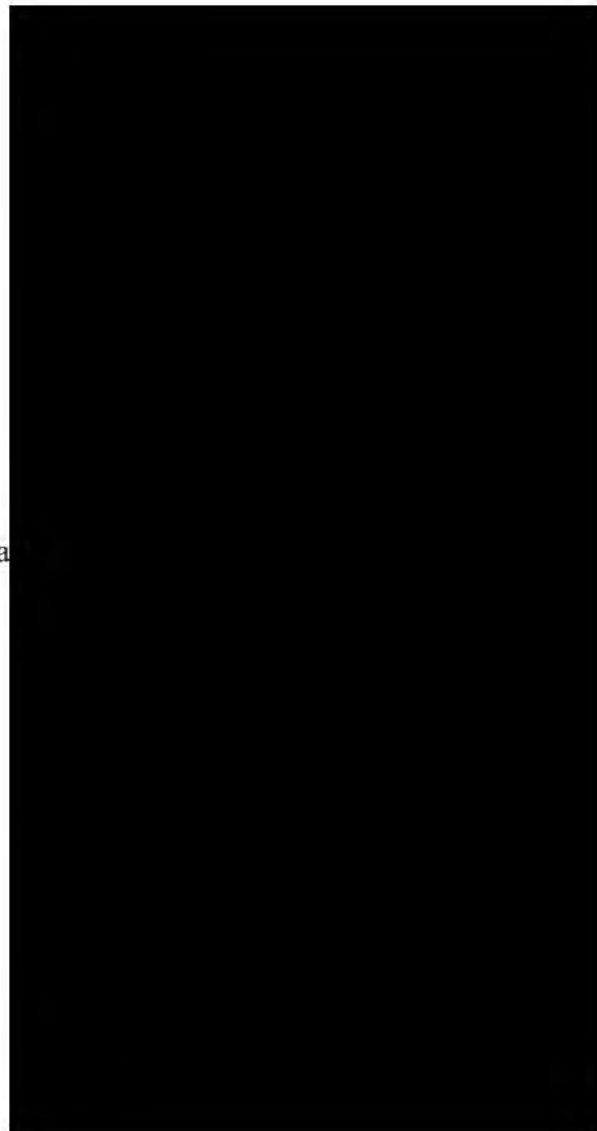
RESOLUTION 09-01-18-00




do meet the requirements for enrollment into the Minnesota Chippewa tribe.
