**RESOLUTION 09-01-48-00**

**A RESOLUTION APPROVING THE ENROLLMENT INTO THE MILLE LACS BAND OF OJIBWE, DUE TO AN INCREASE IN THEIR BLOOD QUANTUM.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applications enrollment; and,

WHEREAS, the Mille Lacs Band Assembly has reviewed the application to reconsider the blood quantum for Darlene Mae (Stromberg) Foote, dob: [REDACTED] establishing her blood quantum as [REDACTED] and,

WHEREAS, based on the blood quantum increase of Darlene Mae (Stromberg) Foote, her child Jordan Carl Foote dob: [REDACTED] is eligible for enrollment; and,

WHEREAS, the resolution denying Jordan Carl Foote's enrollment is Resolution 07-02-05-97 dated October 11, 1996; and,

WHEREAS, the changes should be made on the records of the Minnesota Chippewa Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above applications for enrollment and approves all rights provided for the Minnesota Chippewa Tribe enrollees.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 13th day of April, 2000 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


