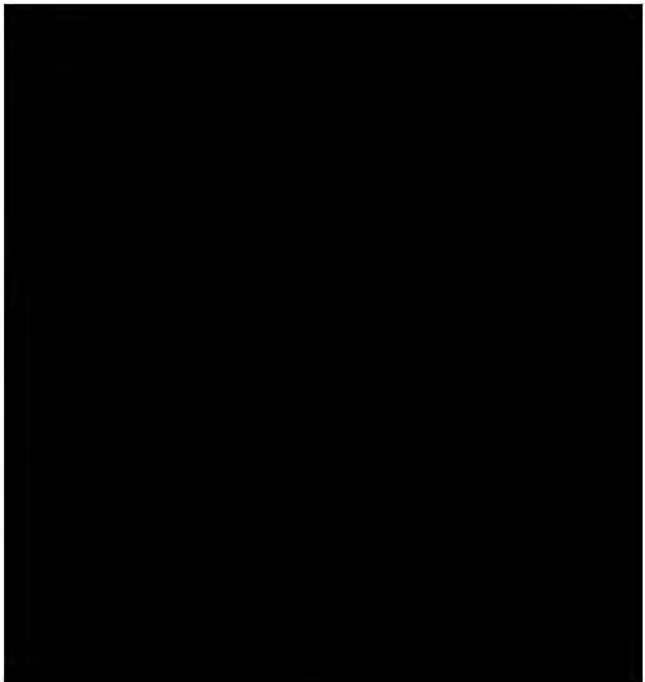
RESOLUTION 09-01-43-00


