RESOLUTION 08-04-16-00

A RESOLUTION TERMINATING A RESIDENTIAL LAND LEASE TO
[REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a homesite or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and;

WHEREAS, a Residential Lease was authorized by Resolution 05-03-106-93 for [REDACTED] [REDACTED] for the purpose of acquiring a Minnesota Chippewa Tribe Home Loan and establishing residence, on the property described herein, and;

WHEREAS, [REDACTED] has requested that the aforementioned lease be terminated since he is selling the home and he has purchased a home as his new residence, and;

WHEREAS, said land is described as follows:

That part of the Northeast Quarter of the Southwest Quarter, Section 18, Township 43 North, Range 27 West, of the Fourth Principal Meridian, in Mille Lacs County, Minnesota, described as following: Commencing at the Southeast corner of said Northeast Quarter of the Southwest Quarter, thence North 00 degrees 53 minutes 33 seconds west 33.00 feet along the East line of said Northeast Quarter of the Southwest Quarter; thence North 89 degrees 58 minutes 27 seconds West 100.00 feet to the point of beginning; thence North 00 degrees 53 minutes 33 seconds West 200.00 feet; thence North 89 degrees 58 minutes 33 seconds East 200.00 feet; thence South 89 degrees 58 minutes 27 seconds East 100.00 feet to the point of beginning. Certificate of survey completed 08-01-1989 and recorded at Aberdeen Land Records and Titles Office, Bureau of Indian Affairs with Document number 410 728(Residential Lease-[REDACTED])

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves that the lease authorized by Resolution # 05-03-106-93 for [REDACTED] [REDACTED] be terminated immediately.
