RESOLUTION 09-01-54-00

**A RESOLUTION APPROVING THE SUBMISSIONS OF THE INDIAN
COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION FOR
THE REHABILITATION PROJECT**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band of Ojibwe will apply for the Indian Community Development Grant for the Rehabilitation of Homes Project; and,

WHEREAS, the Mille Lacs Band is requesting Indian Community Development Block Grant Funding of \$500,000 and will appropriate Tribal Funding of \$189,000; and,


WHEREAS, to provide Band Members an opportunity to review and comment on the application and proposed use of funds, a presentation was made on the Mille Lacs Band's Indian Community Development Grant Application at the Mille Lacs Reservation Housing Authority meeting on May 11, 2000, and on May 16, 2000 at a Special Band Assembly meeting. Also, a summary of the Mille Lacs Band's Indian Community Development Grant Application was posted at the Community Centers in District I, II & III requesting comments from Band Members be submitted to the MLRHA office; and,

WHEREAS, included in the application are Rehabilitation policies and procedures that will be applied to this project. The rehabilitation projects will comply with Commissioner's Order 041-99.

NOW, THEREFORE IT IS RESOLVED, that the Band Assembly for the Mille Lacs Band of Ojibwe Indians concurs with the documentation submitted to the HUD Eastern Woodlands Office of the Native American Programs.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17th day of May, 2000 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of the Assembly to be affixed to this resolution and forwarded to the Chief Executive for concurrence.


