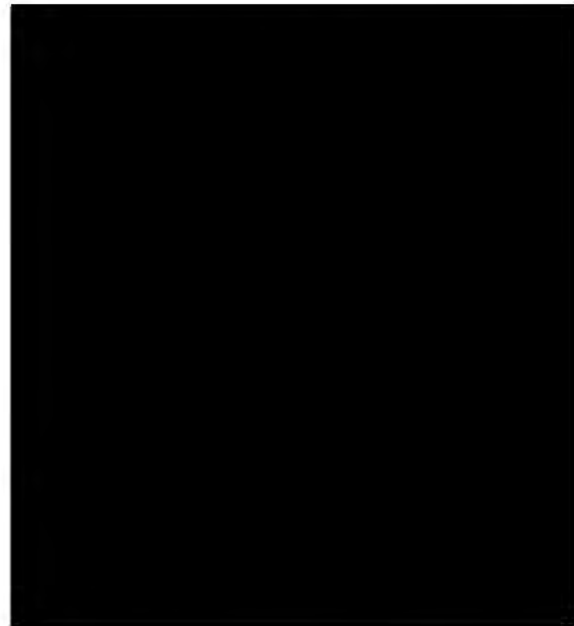
RESOLUTION 09-01-60-00




