**RESOLUTION 09-04-100-01**

**A RESOLUTION RESCINDING RESOLUTION 09-02-82-00  
AUTHORIZING A RESIDENTIAL LAND LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution 09-02-82-00 authorized a lease to be issued to [REDACTED] for the purpose of establishing a home-site for his residence; and,

WHEREAS, the lease was authorized for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,

WHEREAS, said land is described as follows:

A part of Tract # 410 T 1032, Westwood Wellen Survey Job# 20005588, dated 06-27-2000, Lot 4, Block 1, Virgo Development Site, a part of Government Lot 1, Section Seventeen (17), Township Forty-three (43) North, Range Twenty-seven (27) West, Fourth Principal Meridian, Mille Lacs County, Minnesota. See attached map.

The lease rental is \$1.00 and there is a \$2.00 lease processing fee.

WHEREAS, cancellation of Resolution #09-02-82-00 is being requested due to applicant not completing activities required by the lease process; and

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of Band Resolution #09-02-82-00; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe.


