RESOLUTION 09-04-98-01

A RESOLUTION RESCINDING RESOLUTION # 13-85 FOR [REDACTED]

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution #13-85, authorized a lease to be given to [REDACTED]; and
- WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,
- WHEREAS, said land is described as follows:

Southeast one-quarter (SE ¼) of the Northwest one-quarter (NW ¼), Lot 5, Section Twenty-eight (28), Township Forty-three North (T43N), Range Twenty-seven West (T27W), of Vineland Hills Map.

Located on Tract # 410 T 1007

- WHEREAS, Cancellation of Resolution #13-85 is being requested by the Lessor due to non-use of the referenced property and [REDACTED] is requesting a lease at another site; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of Band Resolution #13-85;

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 14th of August, 2001 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.




