RESOLUTION 09-03-61-01

***A RESOLUTION RESCINDING RESOLUTION 07-04-119-97 FOR**
[REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution 07-04-119-97, authorized a lease to be given to [REDACTED] and [REDACTED]

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,

WHEREAS, said land is described as follows:

That part of Government Lot Seven (7), Section Eighteen (18), Township Forty-three (43) North, Range Twenty-seven (27) West, Mille Lacs County, Minnesota described as follows:

Commencing at the northeast corner of said Government Lot 7, thence North 89 degrees 45 minutes 26 seconds West, assumed bearing, 429.96 feet along the north line of said Government Lot 7; thence South 0 degrees 14 minutes 34 seconds West 233.00 feet to the point of beginning of the tract of land to be described; thence continuing South 0 degrees 14 minutes 34 seconds West 200.00 feet; thence North 89 degrees 45 minutes 26 seconds West 200.00 feet; thence North 0 degrees 14 minutes 34 seconds East 200.00 feet; thence South 89 degrees 45 minutes 26 seconds East 200.00 feet to the point of beginning.

WHEREAS, Cancellation of Resolution 07-04-119-97 is being requested by the Lessor due to non-use by the Lessee; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of Band Resolution 07-04-119-97; and,


