RESOLUTION 09-03-62-01

***A RESOLUTION RESCINDING RESOLUTION 08-01-98-98 FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution 08-01-98-98, authorized a lease to be given to [REDACTED] and [REDACTED]

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, for the home located on the site described herein, subject to the lease provisions, effective upon date of approval; and,

WHEREAS, said land is described as follows:

A part of Tract 410 TF 83

A site 190 feet by 30 feet by 157 feet located in the Southeast one-quarter (SE ¼) of the Northeast one-quarter (NE ¼), Section Thirty Three (33), Township Forty-two North (T42N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota (see attached aerial photo and map. The aerial photo shows points taken with GPS unit and lists coordinates of the boundary for this leasesite.) Lessee has right to use existing driveway for access to and from the lease site only, also marked on the map; and

WHEREAS, Cancellation of Resolution 08-01-98-98 is being requested by the Lessor due to transfer of the home to Mille Lacs Reservation Housing Authority (MLRHA) for management and rehabilitation, or replacement.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of Band Resolution 08-01-98-98; and,

BE IT FURTHER RESOLVED, that the land hereby reverts back to the Mille Lacs Band of Ojibwe.


