**RESOLUTION 09-02-14-01**

**A RESOLUTION CANCELLING A LEASE AUTHORIZED BY  
RESOLUTION # 06-04-145-95 FOR A LAND LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #06-04-145-95 authorized a lease to be given to [REDACTED]; and,

WHEREAS, the lease was for a period of 5 years plus 5 years renewal, subject to the lease provisions, effective upon October 25, 1995, for the property described herein; and,

WHEREAS, said land is described as follows:

Section Three (3), Township Forty-two (42) North, Range Twenty-six (26) West, Fourth Principal Meridian, Mille Lacs County, Tract # 410 TF 17, further described as follows:

Lots One (1) thru Four (4), Block Six (6), Sandums Vineland

WHEREAS, a Cancellation of Land Use Agreement for the lease authorized by Resolution #06-04-145-95 [REDACTED] is being requested by Lessor due to non-use and non-payment of rent; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of Land Use Agreement for the lease authorized by Band Resolution #06-04-145-95; and,




BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe.
