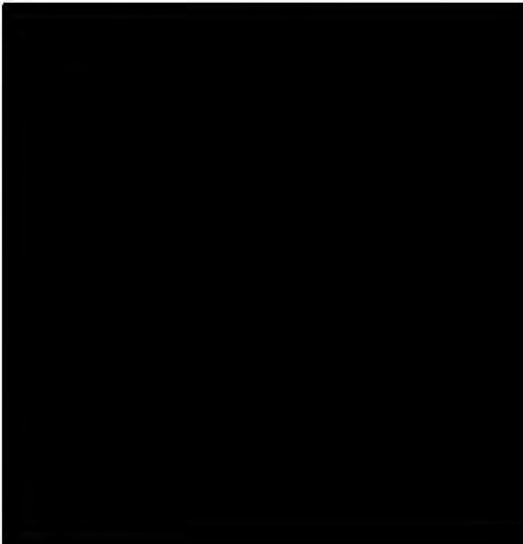
RESOLUTION 09-04-85-01




