RESOLUTION #09-04-105-01

A RESOLUTION RESCINDING RESOLUTION # 05-03-59-93 MODIFIED BY RESOLUTION # 08-01-108-98 FOR [REDACTED] AND [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #05-03-59-93 which was never approved but was modified by Resolution #08-01-108-98, to [REDACTED] [REDACTED] authorized a Land Use Agreement, to the subject property for the purpose of establishing a residential site; and,

WHEREAS, the Land Use Agreement was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective December 16, 1992, for the property described herein; and,

WHEREAS, said land is described as follows:

Lot 5, Block 2, Vineland Hills Addition, Fourth Principal Meridian, Mille Lacs County, also a part of the Southwest One-quarter (SW ¼) of the Northwest One-quarter (NW ¼), Section Twenty-eight (28), Township Forty-three (43) North, Range Twenty-Seven (27) West, with frontage of West Side Road.

WHEREAS, [REDACTED] are requesting the resolution be rescinded due to construction of replacement home for the aforementioned at another site.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby rescinds Band Resolution #05-03-59-93, modified by Resolution #08-01-108-98 for the property described herein and that the Mille Lacs Band Corporate Commission is to construct a replacement home at another site for [REDACTED] and

BE IT FURTHER RESOLVED, that the property described herein will revert back to the Mille Lacs Band of Ojibwe, and;




