**RESOLUTION 09-02-08-01**

**A RESOLUTION REQUESTING TO ADD THE FOLLOWING ROADS  
TO THE BIA ROADS SYSTEM.**

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe; a Federally-recognized Indian Tribe; and,

WHEREAS, the Mille Lacs Band of Ojibwe have contracted under the provisions of the P.L. 93-638 to conduct transportation planning activities; and

WHEREAS, in order to identify and more effectively identify the transportation needs of the Reservation, a new road construction priority needs to be established.

NOW THEREFORE BE IT RESOLVED, that we the Mille Lacs Reservation Band Assembly do hereby establish the following priorities for road construction projects.

Route 0063 located in Aitkin County, Section 21, T. 47N, R. 23W, having a length of approximately 1.19 miles, grade, drain, gravel base and bituminous surface.

Route 0064 located in Mille Lacs County, Section 18, T. 43N, R. 27W, having a length of approximately 0.3 miles, clear, grade, drain, gravel base and bituminous surface.

Route 0065 located in Mille Lacs County, Section 1, T. 42 N, R. 25W, having a length of approximately 0.66 miles, clear, grade, drain, gravel base and bituminous surface.

Route 0066 located in Mille Lacs County, Section 20 and 29, T. 43N, R. 27W, having a length of approximately 0.81 miles, clear, grade, drain, gravel base and bituminous surface.

Route 0067 located in Mille Lacs County, Section 28, T. 43N, R. 27W, having a length of approximately 0.68 miles, clear, grade, drain, gravel base and bituminous surface.

Route 0068, Davis Drive located in Pine County, Barry Township, located in section 14, T. 41N, R 20W, having a total length of approximately 0.6 miles.

Route 0069, Wilderness Estates located in Pine County, Omega Township, located in section 3 & 4, T. 41N, R 17W, having a total length of approximately 3.6 miles.




