RESOLUTION 09-03-44-01

**A RESOLUTION TO CANCEL LEASE AUTHORIZED BY RESOLUTION
#05-04-10-94 FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #05-04-10-94, authorized a lease to be given to [REDACTED] for the purpose of obtaining a MCT home loan; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,

WHEREAS, said land is described as follows:

Commencing at the Southeast corner of Lot C, thence East 1 degree 51 minutes 57 seconds North for a distance of 200 feet., thence East along the Southerly line of County State aid Highway 35 for a distance of 100 feet., thence South a distance of 200 feet., thence West a distance of 100 feet. to point of beginning., all in Government Lot Two (2), Section Seventeen (17), Township Forty-three (43) North, Range Twenty-seven (27) West, Fourth Principal Meridian, Mille Lacs County, Minnesota (known as Parcel D in Maple Hills Addition)


WHEREAS, [REDACTED] is deceased (date of death April 24, 1999) and MCT has an opportunity to sell the home to another Band member.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of the lease authorized by Band Resolution #05-04-10-94; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe for lease to another Band member.


WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 20th of March, 2001 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
