RESOLUTION 09-03-60-01

***A RESOLUTION RESCINDING RESOLUTION 04-02-18-91 THAT
GRANTED A LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution 04-02-18-91, granted a lease to [REDACTED] and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective October 31, 1990, for the property described herein; and,

WHEREAS, said land is described as follows:

Lot 2 of the subdivision defined as Hinckley East. Located in the West one-half (W ½) of the Northwest one-quarter (NW ¼) of the Northeast one-quarter (NE ¼) of Township Forty-one North (T41N), Range Twenty West (R20W) known as Barry Township, Fourth Principal Meridian, Pine County, Minnesota; and

WHEREAS, [REDACTED] is applying for a new lease site and a lease was never completed for this site.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby rescinds Band Resolution 04-02-18-91 in order to process [REDACTED] application for a new lease site; and,

BE IT FURTHER RESOLVED, that the land hereby reverts back to the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being quorum present held on the 29th of May, 2001 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


