RESOLUTION 09-04-107-01

A RESOLUTION RESCINDING RESOLUTION # 09-03-45-01 FOR

[REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #09-03-45-01, authorized a residential lease to [REDACTED] for the purpose of obtaining financing from the United States of America, acting through the Rural Housing Service for the purchase of a home owned by the Minnesota Chippewa Tribe, located on the property described herein; and

WHEREAS, the lease was for a period of 38 years with an option to renew for an additional 12 years by Rural Housing, subject to the lease provisions, at an annual rental rate of \$1.00 and a & 2.00 lease processing fee effective upon date of approval; and

WHEREAS, said site is located within Tract #410 T 1032 and is described as follows:

Westwood Wellen Associates Certificate of Survey, Job #20005878, dated 12-29-2000, that part of Government Lot Two (2), Section Seventeen (17), Township Forty-three (43) North, Range Twenty-seven (27) West, Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows: Parcel C.

WHEREAS, Cancellation of Resolution #09-03-45-01 is being requested by the Lessor due to Bonita's purchase agreement expiring and the Minnesota Chippewa Tribe's sale of the home to another individual on the property described herein.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of Band Resolution #09-03-45-01; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 26th of March 2002 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


