RESOLUTION 09-04-92-01

**A RESOLUTION TO MODIFY RESOLUTION 77-84 FOR [REDACTED]
[REDACTED] GRANTING A LAND LEASE.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution 77-84 authorized a lease to [REDACTED] to the subject property for the purpose of establishing a home-site; and,

WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective September 25, 1984, for the property described herein; and,

WHEREAS, Resolution 77-84 did not include a complete legal description; and,

WHEREAS, said land description is modified as follows:

A part of Tract # 410 T 1002, located in the North one-half (N ½) of the Northeast one-quarter (NE ¼) of Section Twenty-eight (28), Township Forty-three North (T43N), Range Twenty-seven North (R27N), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Seven (7), Block One (1), Vineland Hills Plat dated March 9, 1982 by Anthony E. Kerrick registered surveyor # 12266.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes modification of the lease to include complete legal description issued to [REDACTED] through Resolution #77-84. All other terms and conditions shall remain the same, effective September 25, 1984; and,

BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and,




