RESOLUTION 09-03-65-01

A RESOLUTION RESCINDING RESOLUTION 05-03-74-93 THAT GRANTED A LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution 05-03-74-93, granted a lease to [REDACTED] and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective February 5th, 1993, for the property described herein; and,

WHEREAS, said land is described as follows:

Part of Tract 410 T 60

Beginning at the Southeast (SE) corner of the North One-half (N $\frac{1}{2}$) of the Northeast One-quarter (NE $\frac{1}{4}$) of the Northeast One-quarter (NE $\frac{1}{4}$), thence North 297.8 feet, thence 50 feet West, point of beginning, thence West 150 feet, thence North 100 feet thence East 150 feet, thence South 100 feet, to point of beginning, in Section Twenty-nine (29), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota.

WHEREAS, [REDACTED] is deceased; and,

WHEREAS, the lease document was never completed.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby rescinds Band Resolution 05-03-74-93 since [REDACTED] is deceased; and,

BE IT FURTHER RESOLVED, that the land hereby reverts back to the Mille Lacs Band of Ojibwe.




