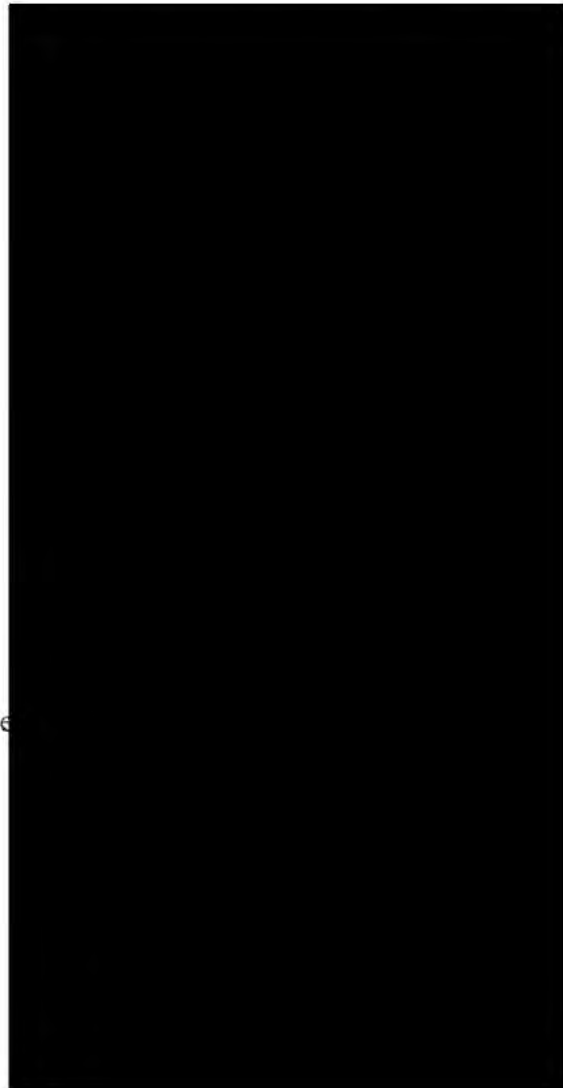
RESOLUTION 09-04-84-01
