**RESOLUTION 09-03-36-01**

**A RESOLUTION RESCINDING RESOLUTION #08-02-18-99 THAT GRANTED A LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #08-02-18-99, granted a lease to [REDACTED] and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective December 4, 1998, for the property described herein; and,

WHEREAS, said land is described as follows:

Parcel A of Central Minnesota Survey Map dated 10/01/98, Job # 985956

That part of Government Lots 6 & 7, Section Eighteen (18), Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Commencing at the Northeast corner of said Government Lot 7; thence North 1 degree 02 minutes 39 seconds West, assumed bearing, 161.13 feet along the Northerly extension of the East line of said Government Lot 7, thence South 88 degrees 44 minutes 27 seconds West 6.44 feet to the point of beginning of the tract of land to be described; thence south 88 degrees 44 minutes 27 seconds West 100.00 feet; thence south 2 degrees 10 minutes 39 seconds East 200.00 feet; thence North 88 degrees 44 minutes 27 seconds East 100.00 feet; thence North 2 degrees 10 minutes 39 seconds West 200.00 feet to the point of beginning.

WHEREAS, [REDACTED] has signed a request for cancellation of the lease authorized by Resolution #08-02-18-99; and,

WHEREAS, the lease document was never completed, and,


