RESOLUTION 10-01-23-02

A RESOLUTION TO CANCEL LEASE AUTHORIZED BY RESOLUTION #24-83 FOR [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #24-83, authorized a tribal land lease to be given to [REDACTED] for the purpose of establishing her home; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,

WHEREAS, said land is described as follows:

A part of Tract # 410T1002, located in the North one-half (N ½) of the Northeast one-quarter (NE ¼) of Section Twenty-eight (28), Township Forth-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota further described as:

Lot 4, Block 3, Vineland Hill Map dated March 9, 1982.

WHEREAS, [REDACTED] is deceased (date of death December 30, 1990) and MCT has an opportunity to sell the home to the Mille Lacs Band of Ojibwe

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Cancellation of the lease authorized by Band Resolution #24-83; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe for lease to another Band member.


