





JOINT RESOLUTION 10-02-83-02

A RESOLUTION APPROVING THE ENROLLMENT INTO THE MILLE LACS BAND OF OJIBWE, DUE TO AN INCREASE IN THEIR BLOOD QUANTUM.

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, the Mille Lacs Band Assembly screens all membership considerations and has reviewed the following applications enrollment; and,
- WHEREAS, the Mille Lacs Band Assembly has reviewed the application to reconsider the blood quantum for DeEtta Marie Weyaus, dob: [REDACTED] establishing her blood quantum as [REDACTED] and,
- WHEREAS, based on the blood quantum increase of DeEtta Marie Weyaus, her child Renee Violet Weyaus dob: [REDACTED] is eligible for enrollment; and,
- WHEREAS, the resolution denying Renee Violet Weyaus' enrollment is Resolution 06-03-180-95 dated January 11, 1995; and,
- WHEREAS, the changes should be made on the records of the Minnesota Chippewa Tribe.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above applications for enrollment and approves all rights provided for the Minnesota Chippewa Tribe enrollees.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 18th day of July, 2002 at Onamia, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
- IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of the Assembly to be affixed to this resolution and forwarded to the Chief Executive for Concurrence.


