RESOLUTION 10-02-80-02

A RESOLUTION AUTHORIZING THE MILLE LACS BAND COMMUNITY DEVELOPMENT DEPARTMENT TO DEVELOP PLANS AND CONSTRUCT HOUSING FOR MILLE LACS BAND MEMBERS

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, there is an urgent need for housing for Mille Lacs Band members such that the Department of Community Development has been appropriated funds to be used in the Housing Initiative Plan through Band Assembly Bill 09-03-13-01 to provide Band housing; and,
- WHEREAS, the provision of Band housing includes the cost of subdivision design, infrastructure design and construction, and environmental evaluation and assessment preparation in addition to housing construction costs, and
- WHEREAS, the Department of Community Development, respectfully requests permission to proceed with development of residential site plans, infrastructure design and construction, and building construction for sites targeted for new housing without a lease; and,
- WHEREAS, the Department of Community Development will only be allowed to proceed on those sites when the following requirements have been met:
 - 1. Approved Application
 - 2. Completed Survey
 - 3. Completed Environmental Assessment (EAW)
- WHEREAS, the Department of Community Development will use the followings sites described herein for development under the Housing Initiative Plan; and
- WHEREAS, said land is described as follows:

District I (13 Sites)

Commencing at a Global Positioning System (GPS) coordinate (539,328.41; 5,101,275.77) the point of beginning, thence bearing South 34 degrees 9 minutes 35 seconds East a distance of 187.89 feet; thence bearing South 54 degrees 38 minutes 15 seconds West a distance of 211.07 feet; thence North 38 degrees 23 minutes 12 seconds West a distance of 181.82 feet; thence North 53 degrees 2 minutes 9 seconds East a distance of 224.69 feet to the point of beginning (GPS coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points). - WHEREAS, upon completion of the housing projects occurring on the sites listed above, a resolution and lease will be processed for the Mille Lacs Reservation Housing Authority to operate and maintain the homes utilizing MLRHA policies and procedures.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes the Community Development of the Mille Lacs Band to proceed with the development of residential site plans, infrastructure design and construction, and building construction for the sites mentioned above without a lease, upon completion of an approved application, completed survey and completed environmental assessment (EAW) for each site; and,
- NOW, THEREFORE, BE IT FURTHER RESOLVED, upon completion of the housing projects, a resolution and lease will be processed for the Mille Lacs Reservation Housing Authority to operate and maintain the homes utilizing MLRHA policies and procedures.
