RESOLUTION 10-01-59-02

**A RESOLUTION TO RESCIND LEASE AUTHORIZED BY
RESOLUTION #04-38-86 FOR [REDACTED] ALSO
KNOWN AS [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolution #04-38-86, authorized a tribal land lease to be given to [REDACTED] for the purpose of establishing a home; and,

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective February 13, 1986, for the property described herein; and,

WHEREAS, said land is described as follows:

That part of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 17, Spalding Township 47N, Range 23 W, Aitkin County. Lot 9 as defined by the General Development Plan Mille Lacs Housing Site, Bureau of Indian Affairs C.A. Hammond - July 24, 1969; and,

WHEREAS, [REDACTED] is deceased and there is no home currently located on the site described herein.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of the lease authorized by Band Resolution #04-38-86; and,

BE IT FURTHER RESOLVED, that the land will revert back to the Mille Lacs Band of Ojibwe for lease to another Band member.


