## **RESOLUTION 10-01-67-02**

A RESOLUTION AUTHORIZING A TEMPORARY AND PERMANENT ROAD RIGHT-OF-WAY FOR RECONSTRUCTION AND MAINTENANCE OF ONAMIA TOWNSHIP 360<sup>TH</sup> ROAD PROJECT AS PROPOSED IN PLANS FOR FEMA PROJECT # 095-48328-00, ONAMIA, MILLE LACS COUNTY, MINNESOTA

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, Onamia Township respectfully requests a 67 feet by 200 feet permanent easement for a culvert and a temporary easement for the maintenance and reconstruction of Onamia Township 360<sup>th</sup> Street Road Project as proposed in plans for FEMA project # 095-48328-00; and,
- WHEREAS, the right-of-way easement will be for a period of 50 years, subject to the terms of the right-of-way document, effective upon date of approval, for the property described herein; and,
- WHEREAS, said land is described as follows:

A part of TRACT# 410 TF 111 described as:

Temporary Easement 1: The North Seven (7) Feet of the South Forty (40) feet of the Southwest One-quarter (1/4) of the Southeast One-quarter (1/4) of Section Thirty-two (32), Township Forty-two North (T42N), Range Twenty-six West (R26W) Containing .21 acres more or less, and

Temporary Easement 2: The South Seventeen (17) feet of the North Fifty (50) feet of the Northeast One-quarter (½) of Section Five (5), Township Forty-one North (T41N), Range Twenty-six West (R26W), except the East Two-hundred (200) feet of the West One thousand one hundred forty six point two-two (1146.22) feet thereof and the South Seventeen (17) feet of the North Fifty (50) feet of the Northeast One-quarter (NE ½) of the Northwest One-quarter (NW ½) of said Section 5, T41N, R26W containing 1.47 acres more or less, and

Temporary Easement 3: The West Fifty (50) feet of the South Eight hundred fifty (850) Feet of the North Nine hundred (900) Feet of the Northeast One-quarter (NE ¼) of the Northwest One-quarter (NW ¼) of Section Five (5), Township Forty-one North (T41N), Range Twenty-six West (R26W) containing .98 acres more or less, and

Permanent Easement: The East Two hundred (200) feet of the West One thousand one hundred forty six point two-two (1146.22) feet of the South Sixty-seven (67) feet of the North One hundred (100) feet of the Northwest One-quarter (NW ¼) of the Northeast One-quarter (NE ¼) of Section Five (5), Township Forty-one North (T41N), Range Twenty-six West (R26W), containing .31 Acres more or less

All of the above Easements are located in the Fourth Principal Meridian, Mille Lacs County, Minnesota. See map attached as Exhibit A

- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes a right-of-way easement, including a temporary easement, to Onamia Township for road purposes only under FEMA Project Number 095-48328-00 for the afore described property, in perpetuity, subject to terms of the right-of-way document, effective upon date of approval; and,
- BE IT FURTHER RESOLVED, that Onamia Township will utilize the land in conformity with the provisions of the right-of-way agreement, and if all terms of the agreement are not met, the land will revert back to the Mille Lacs Band of Ojibwe; and,
- BE IT FURTHER RESOLVED, that the right-of-way shall be null and void should Onamia Township abandon or vacate the above-described property and the subject property will automatically revert to the Mille Lacs Band of Ojibwe; and,
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a of legislators being quorum present held on the \_\_4th of June, 2002 at Isle, Minnesota by a vote of \_3 FOR, \_o AGAINST, 0 SILENT.
- IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of the Assembly to be affixed to this resolution.
